TUPE Regulations

- 2014 changes:
 - Service provision changes and activities being "fundamentally or essentially the same".
 - Employee Liability Information.
 - Transferees ability to make positive changes to collective agreements.
 - Change in location included to ETO reason.
 - Pre transfer collective consultation permitted under TULR(C)A.
 - Micro businesses can inform and consult affected employees directly.

- EC Procedure.

- Fees introduced into Employment Tribunals on 29 July 2013 by way of the Employment Tribunals and the Employment Appeal Tribunal Fees Order 2013.
- Type A and type B claims.
- Issue fee.
