Charity tax made simple
Are you new to the charity sector or want a tax refresher? Tax issues are particularly complicated for charities. This session will cover, at a high level, VAT, Gift Aid, trading and business rates.

Introduction to charity law & update on recent developments
This session will cover the basics of charity law that you need to know as well as an update on recent legal and regulatory changes impacting charities.

Providing assurance on management of risk
Boards need confirmation that key risks are being identified and effectively managed. Based on Sayer Vincent's evolving thinking on risk, this session will outline how to provide assurance using practical approaches.

Tools and techniques for creative problem solving
In our sector the challenges come at us thick and fast; poor public perception; unsupported projects; people understand the finance brief; the board ignore my financial advice based on data? Change the way you think to find new ways of overcoming challenges.

Introduction to SORP
A session for those new to the sector and those wanting a refresher. This session will focus on the aspects of SORP that pose the biggest headaches for charities.

Making the Treasurer and Finance Director's relationship work
Together the Finance Director and the Treasurer have responsibility for the financial management and oversight of a charity. How do you work with your Treasurer? What are the key features of making this relationship work?

IT project management
Finance Directors often have IT responsibility too. Many major IT projects run into management difficulties and cost overruns. This session will consider how you can avoid the nasty shocks that major IT projects can bring.

Manager as coach
ILM research says that managers who employ coaching as a development tool see tangible benefits. It's common that managing people is more effective from a coaching, rather than managing, perspective. Help others, to help themselves and grow in their role, as well as see benefits for you, the manager.

Focus on charity governance
